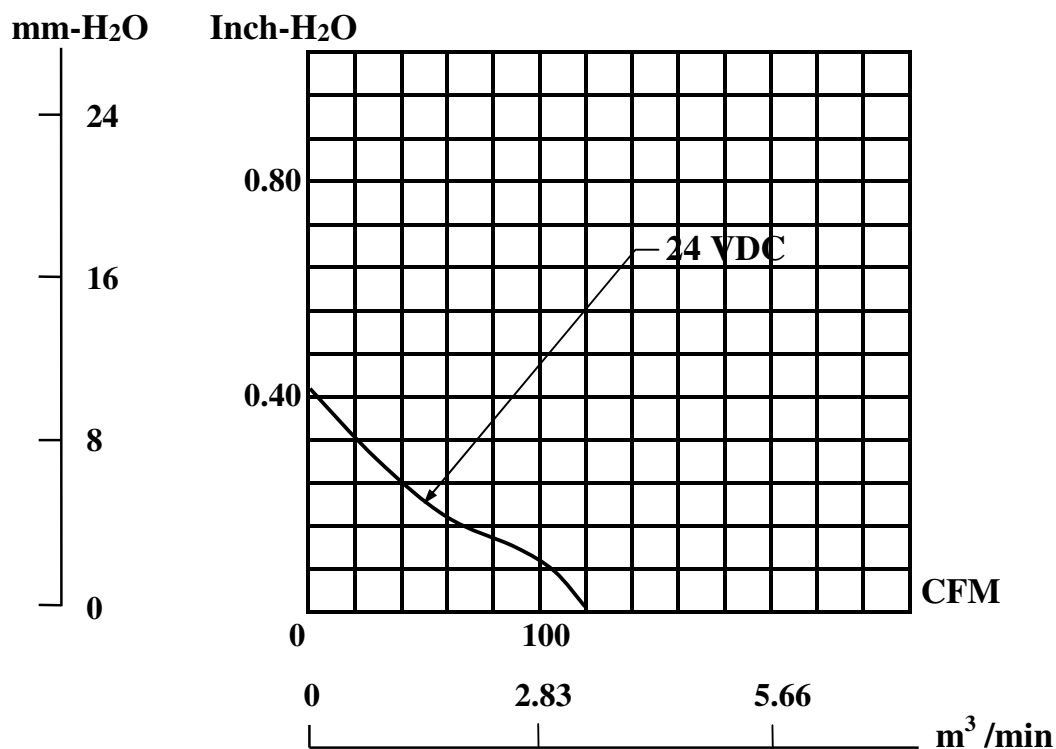

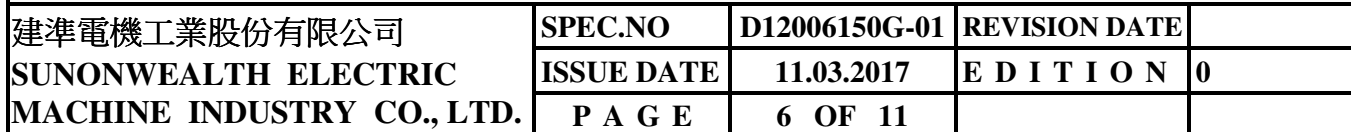

PRESSURE**



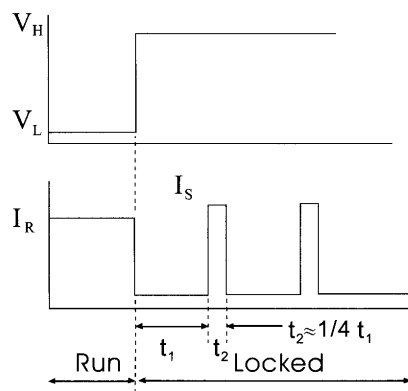

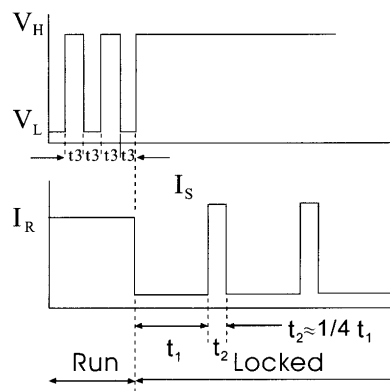
