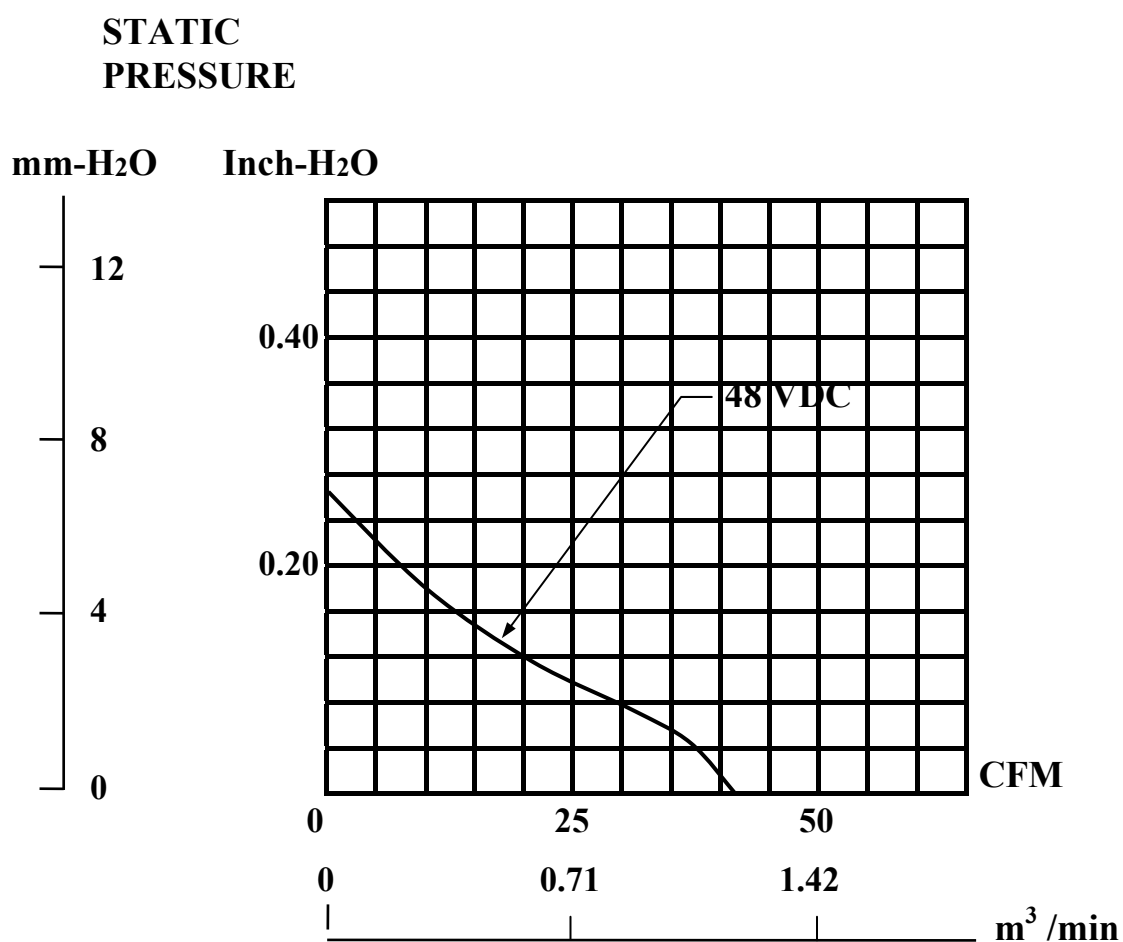

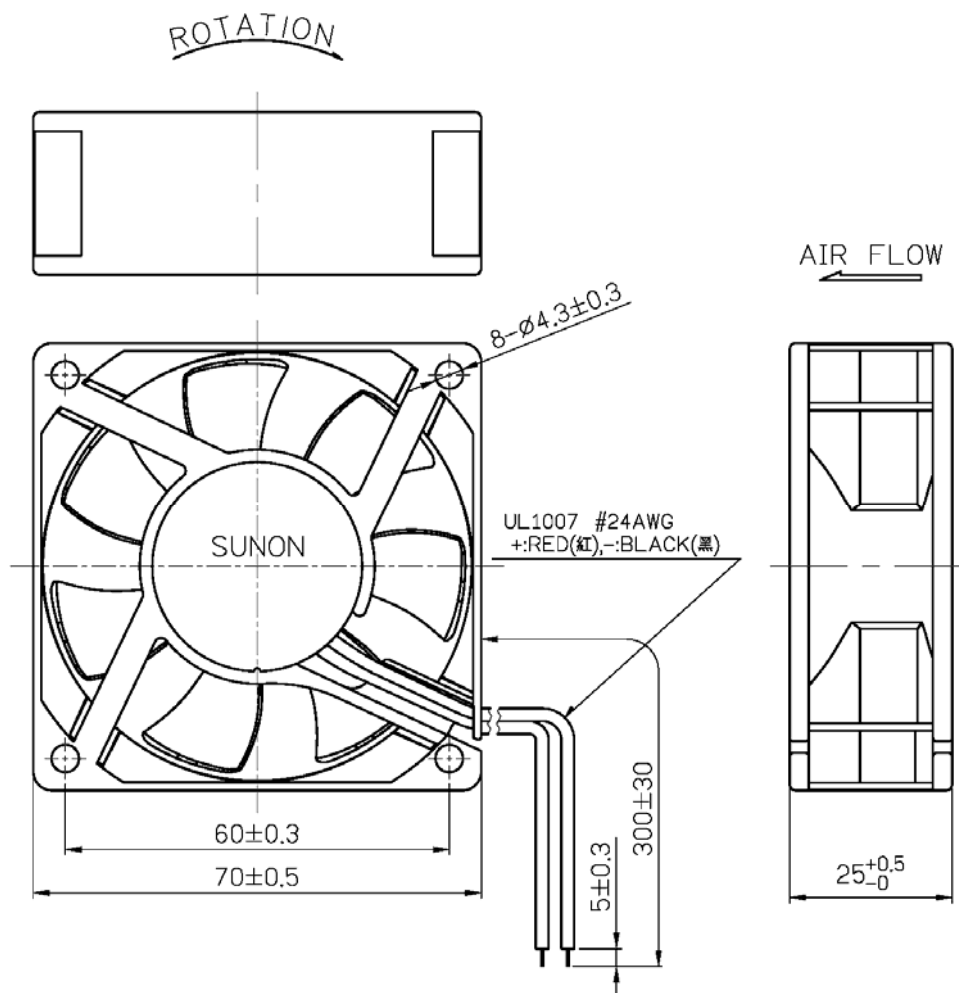
PERFORMANCE CURVES
