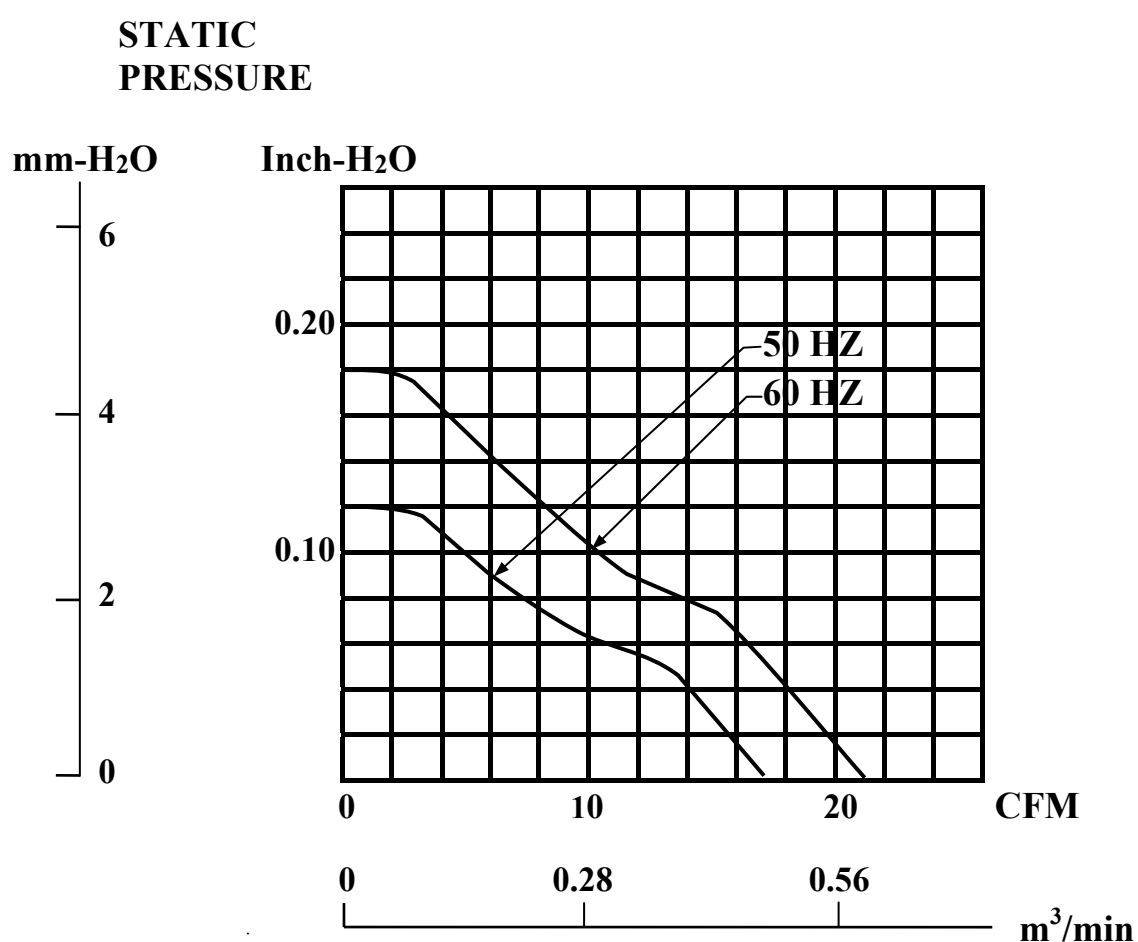

## PERFORMANCE CURVES

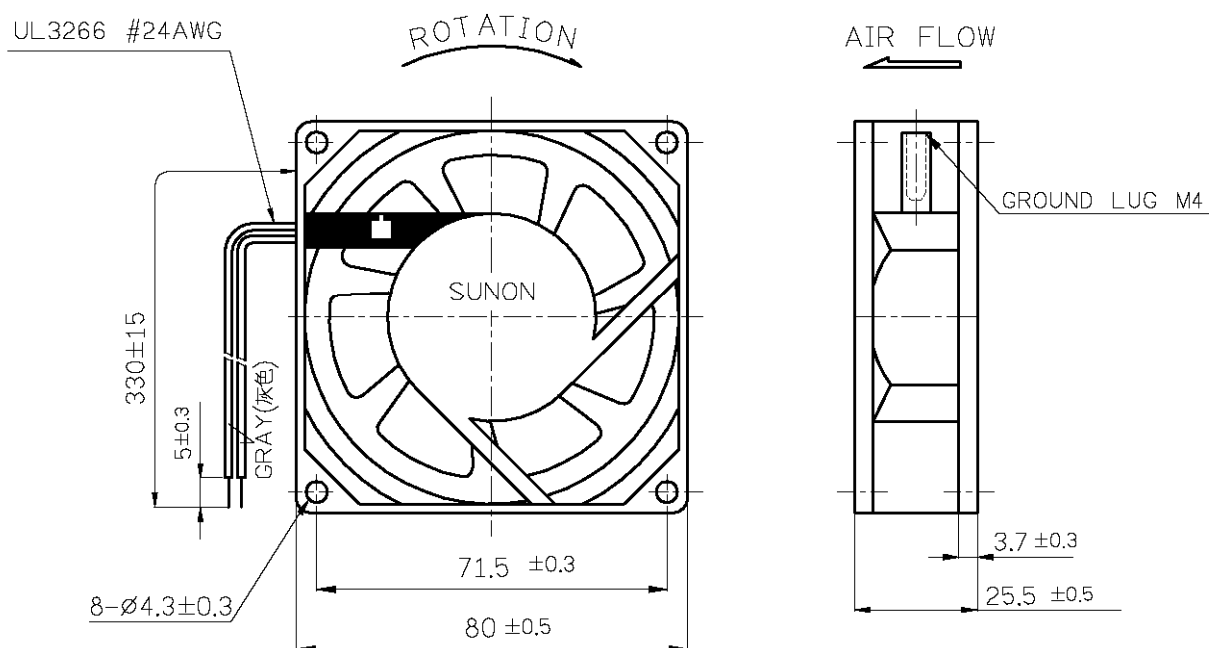
